#### Hold the date

The Australian Political Studies Annual Conference will meet at the University of Sydney from Sunday 28<sup>th</sup> September to Wednesday 1<sup>st</sup> October 2014.

The event will feature a plenary roundtable moderated by Professor Guy Lachapelle (IPSA General Secretary, University of Concordia) on 'Contemporary Challenges of Electoral Integrity', featuring several members of the IPSA Executive.

The IPSA Executive Committee will hold its meeting in conjunction with the event. The APSA Executive will also meet in Sydney. Sunday also features five thematic all-day workshops followed by an opening wine and cheese early evening reception in the New Law School Building for workshop participants.

The packed program for the remaining main days of the conference offers delegates a choice of one hundred panels organized into seven thematic streams, including the main conference theme, on 'Elections, Democracy and Autocracy.' The event attracted a record number of around 600 paper proposals, including around 150 international participants from more than thirty countries. Proposals have now been carefully reviewed by the Program Committee. Those who have been accepted have been notified and the Program Committee is now in the process organizing the papers into thematic panels, each with a discussant and chair. The Conference Program and schedule will go live on the conference website, www.apsa2014.com, on 1st June.

The event will also feature several other social networking events. On Monday evening APSA hosts a welcoming reception for all delegates and a prizegiving ceremony with drinks and canapés downtown at the New South Wales Parliament, Sydney. The 8-course conference dinner on Tuesday will be held in the famous Marigold Restaurant in Chinatown and tickets can be purchased separately for the bargain price of \$38 (not inclusive of drinks). There will also be opportunities for optional sign-up cultural and tourism events, such as a Harbor cruise, and a book exhibit.

Conference registration rates are greatly reduced from previous annual meetings and the early-bird rate closes at 5pm on 10<sup>th</sup> June. All conference participants need to register to attend the event, including students. To do so, go to the conference website, <a href="www.apsa2014.com">www.apsa2014.com</a>. The early bird rate saves a considerable discount (\$50) over the standard rate.

#### **NZPSA Conference 2014**

Second Round Call for Papers Venue: University of Auckland Dates: 1<sup>st</sup>-3rd December 2014 (conference) 30<sup>th</sup> November (postgraduate workshop)

Thank you to all applicants for the first round call for the New Zealand Political Studies Association 2014 annual conference, which closed on 15<sup>th</sup> May. We received more than 180 abstracts from 28 countries, setting the foundation for an exciting conference this year. Acceptances from round one will be sent out by 1<sup>st</sup> July 2014.

A second - and final - round for additional submissions has now opened, with a due date of **30**<sup>th</sup> **June 2014.** The organisers encourage paper abstracts (150-200 words) or panel proposals (of up to five papers) that speak to the diverse approaches, issues and methods in the study of politics. These include the following streams:

- New Zealand politics
- Māori and Indigenous politics
- Political theory
- Public policy and administration
- International relations
- Political economy

- Comparative politics
- Environmental politics
- Media politics
- Teaching and learning politics
- · Conference theme

We would also welcome papers on the following theme:

Conflict and discord: Politics in a time of crisis

The political landscape is characterised by conflict and discord. This is most evident during times of sociopolitical and economic upheaval, but also features in the everyday practice of contemporary democratic Issues of voter apathy, cynicism and democratic decline more broadly herald significant challenges for the legitimacy and effectiveness of political institutions. At the same time, new political forces have emerged, challenging established practices and actors. For example, the battle between scientists and climate change deniers continues to rage, while public opinion in New Zealand and Australia is divided over the economic and environmental impacts of offshore drilling, mining and agricultural intensification. Protest movements from Occupy to the Indignados have sprung up calling for a radical rethink in the social, economic and political configuration of society. In the Middle East, the sense of hope that accompanied the initial discord of the Arab Spring has quickly evaporated as a new wave of repressive measures is introduced to clamp down on protestors. By focusing on themes of conflict and discord, we encourage participants to think about changes to the decision-making process and the allocation of power in a society during times of crisis. In what ways does the practice of politics change? To what extent is conflict natural, necessary and perhaps even constructive? What insights can some conflicts, such as those around climate denial, provide for our understanding of political processes?

Particular issues welcomed in the theme include:

- Democratic decline
- Theories of crisis
- Austerity and new social movements
- · Racism, racialization and conflict
- · Retribution and reconciliation
- Conflict and revolutionary change

Submission of second round abstracts and panel proposals: **30**<sup>th</sup> **June 2014.** 

Notification of second round successful submissions:  $\mathbf{1}^{\text{st}}$  August 2014.

## CALL FOR EXPRESSIONS OF INTEREST TO HOST OCIS 2016

The Sixth Oceanic Conference on International Studies (OCIS) will be held at the University of Melbourne on 9-11 July 2014. It has become customary to announce the next OCIS at each biennial conference and we therefore **invite expressions of interest to host OCIS in July 2016** so an announcement can be made at the Melbourne conference.

Detailed information will then be provided on what is required to submit a formal bid, which should be submitted **no later than Friday 6 June 2014.** 

Formal bids will be assessed by the OCIC transition committee, which is broadly representative of the international studies community in the region. The committee shall be guided by the following criteria:

- The conference should be run by a mainstream International Relations, International Studies or Politics Department, Centre or School, with a significant cohort of academic and postgraduates working in the field of International Relations and cognate fields.
- 2. The host should be able to provide the necessary institutional and financial support to ensure a successful conference, and that this should include the ability to offer bursaries for graduate students to a level established in previous conferences.
- 3. Where possible, attention will be given to regional equity so that the conference moves around from state to state, and from Australia to New Zealand.

#### **FAY GALE LECTURE 2014**

The Academy of the Social Sciences in Australia, in conjunction with Monash University, is pleased to present the Academy's 2014 Fay Gale Lecture:

# "WINNING THE WAR ON WAR BUT LOSING THE BATTLE: A FEMINIST PERSPECTIVE ON GLOBAL VIOLENCE"

International relations scholars as well as psychologists have recently claimed that violence - defined largely as homicide and casualties from war – is in steep decline. On these accounts, human beings are becoming more civilised. However, research dedicated to making the case for decline with reference to historical and quantitative data has almost completely neglected evidence of gendered violence. Sexual and genderbased violence (SGBV) has been largely invisible, silent and unreported yet prevalence surveys reveal that the majority of women and girls in every country, that is, a large proportion of the total world population, have experienced this form of violence. According to the cross-national International Violence against Women survey (IVAWS) the number of women who have experienced at least one incident of physical or sexual violence since age sixteen is between 20 and 60 per cent with an average victimisation rate of over 35 per cent. Moreover, declinist perspectives on violence and war seem to go against contemporary reporting of widespread and systematic SGBV especially targeting civilians in genocide, conflict and mass atrocity situations. Violence against women and girls (VAWG) has been the subject of nearly four decades of feminist scholarship, activism and policy interventions. Analysing global violence from a feminist perspective on VAWG radically challenges declinist views and our understanding of the causes, justifications, and consequences of violence.

The Fay Gale Lecture honours the late Professor Gwendoline Fay Gale AO (1932-2008), the first female President of the Academy of the Social Sciences in Australia and an eminent social scientist. Professor Gale was notable for her far-reaching impact on the promotion of gender equity within the university sector.
