APSA Women's Caucus Representative report to APSA Executive, AGM, Perth 2013

The Women's Caucus held its annual meeting at the 2012 APSA conference where Prof. Linda Hancock was elected for a two year term as APSA Women's Caucus Representative

Caucus activities report:

- i) APSA website, the Women's Caucus page has been updated for inclusion in the new APSA web site; including a link to the Facebook page. The list of gender related PhDs has been updated for theses from 2006 to 2012, with a request that additional entries be forwarded to the Women's Caucus Representative.
- ii) The Women's Caucus Representative participated on the update of Journal rankings sub-committee.
- iii) Purple sticker mentoring program was attempted at this year's conference, but needs to be integrated with registration process from next year, with a tick-box for those wishing to self-nominate as mentors. Women's Caucus will liaise with the 2014 conference conveners.
- iv) The 2013 APSA Gender Audit follows up on APSA Executive's response to the Women's Advancement in Australian Political Science report and relates to APSA's undertaking to conduct a gender audit in 2013 and 2016.

The 2013 APSA Gender Audit is being undertaken by the Women's Caucus representative during October 2013, with good cooperation from Heads of schools on requested data relating to full time tenured and contract staff, PhD completions, ARC grants and so on. A second phase will include a survey invitation to all full time, tenured and contract staff in departments in IR, government, politics and public policy included in the audit.

The undertaking to implement a purple sticker mentoring system at APSA conferences will involve liaison with the 2014 Sydney conference. Women's Caucus rep will liaise with conf organisers to implement purple sticker mentoring program through the conference registration form.

Women's Caucus will follow up with the introduction of the Carol Pateman book prize with the Executive in 2014 with details on the APSA web site and rotation with the Women and Politics prize.

As a precursor to formal business, several women leaders in the profession gave short discussions on key aspects of how to organise their careers: how to juggle family and work, how to balance teaching and research, how to respond to reviewers, how to learn from depression that sometimes comes with the job and when to go for promotion.

- 4. Caucus activities report:
- i) APSA website, the Women's Caucus page has been updated for inclusion in the new APSA web site; including a link to the Facebook page. The list of gender related PhDs has been updated for theses from 2006 to 2012, with a request that additional entries be forwarded to the Women's Caucus Representative.
- ii) Journal rankings 2013 APSA list has been updated. There was discussion on expanding the size of the list as there are possibly several thousand political science journals worldwide. There was also discussion on recognising interdisciplinary journals that political science scholars publish in, but that have not been given attention as they are not maintained by any single discipline.
- iii) Purple sticker mentoring program was attempted at this year's conference, but needs to be integrated with registration process from next year, with a tick-box for those wishing to self-nominate as mentors.
- iv) 2013 APSA Gender Audit is being undertaken by Women's Caucus Rep during October 2013 to for comparability with the timing of the 2010 audit, with good cooperation from Heads of schools. Requested data relates to full time tenured and contract staff, PhD completions, ARC grants and so on. Discussion suggested the data could be sent to Deans for confirmation and as a mechanism to of accountability. A second phase will include a survey invitation to all full time, tenured/contract staff in in departments in IR, government, politics and public policy included in the audit. Preliminary data for 2013 suggest a possible improvement compared with 2010 results. The need to exclude casual staff from the audit points to a gap that needs addressing.
- 5. 2014 Sydney conference. a). Women's Caucus rep will liaise with conf organisers to implement purple sticker mentoring program through the conference registration form. b) Suggestion to convene a panel on the State of Women in the Discipline was supported by the meeting. iii) Women's Caucus rep will follow up with the introduction of the Carol Pateman book prize with the Executive with details on the APSA web site and implemented for 2014 conference, and or to alternate with the Women and Politics prize.
- 6. Self-nominations were called for a sub-committee to assist in matters related to the Women's Caucus and Facebook page updates.

Carole Pateman Book Prize for Politics and Gender

- 1. May be awarded to a man or woman
- 2. That is a member of APSA

For a book that:

- 3. Incorporates gender or feminist perspectives into political science
- 4. Demonstrates excellence in writing and communication
- 5. Exhibits scholarly innovation and rigour
- 6. Must published in the preceding four years, but may only be submitted for the prize once

Prize for Academic Leadership

This prize is open to a man or a woman at any level in the profession that is a member of APSA and exhibits inclusive leadership.

The person will need to be nominated by one of their colleagues for this award. Their nomination will be supported by statements by three colleagues or mentees (including at least one woman) about how they exhibit the values of inclusive and collaborative academic leadership.

The nominations for the Award will be assessed by sub committee of the APSA executive with regards to leadership that:

- 1. Supports academic pluralism and the value of diverse approaches to the discipline.
- 2. Encourages academic rigour through constructive feedback about how research can be strengthened
- 3. Mentors and champions both colleagues and emerging scholars
- 4. Demonstrates awareness of the unique challenges confronted by female academics
- 5. Builds research communities and collaborative academic opportunities

3. Report on 'Women's Advancement in Political Science' Workshop

Marian Sawer reported that having successfully won funding for the workshop from APSA and the ANU Gender Institute 40 women would be attending the workshop on Thursday. Some fascinating research has been produced for the workshop and a

professional facilitator had been employed to guide the creation of a clear action agenda coming out of the workshop. The findings would be turned into a report for the APSA executive, and Heads of Depts.

4. Pippa Norris Laureate & Potential Funding for Workshop Initiatives

Professor Pippa Norris has been the inaugural winner of the Kathleen Fitpatrick Laureate for women researchers in humanities and the social sciences. Part of Pippa's proposal for the \$2.6 million ARC prize was that she would fund activities to mentor and develop young female academics and encourage them to stay in academia. She has contacted the Women's Caucus to discuss the best way to spend the funds. We have discussed that her money may be able to be used to fund proposals coming out of the Women's Workshop on Thursday.

5. Women in Political Science Blog

Mhairi Cowden reported that as part of the Women's Workshop a blog had also been established as a place for debating and discussing issues of relevance to women in the discipline. The Web address is:
